Article 1

OBJECTIVE OF COLLABORATION

The objective of this Memorandum of Understanding (MOU) is to collaborate with each other in educational projects in areas of mutual interest.

Article 2

SCOPE OF COLLABORATION

The Parties agree to implement collaborative programmes including but not limited to:

- c. Organizing seminars / webinars / conferences / symposia through blended mode (online and offline).
- d. Sharing of scientific information on areas of mutual interest.
- e. Sharing of resources (online and reading room facilities of the library; laboratory).
- f. Undertaking Joint Research Programmes where possible.
- g. Academic quality-based collaboration, including publications and internships.

Article 3

FINANCIAL ARRANGEMENT

Any collaboration under this MOU is subject to the availability of funding sources and approval of the relevant authorities.

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Shishuram Das College and Sonarpur Mahavidyalaya.
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted in blended mode (offline and online).

Article 6

CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION

Both the institutions shall respect and retain confidentiality in each/any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the colleges, and not any other/commercial interest.

This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

Article 7

DURATION AND TERMINATION

- 1) This MOU shall enter into force on the date of signing.
- 2) The MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by the mutual written consent of the Parties.

Article 8

AMENDMENT

- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
- 2) Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.

Article 9

SETTLEMENT OF DISPUTES

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultations or negotiations between the Parties.


